Product Announcement: Discontinuation of Limited Models of Conventional FACP's

Dear Valued Customer,

Due to component obsolescence, Honeywell will soon no longer be able to build and ship the conventional fire alarm control panels (FACP's) listed in the table below. Existing orders for these FACP's will continue to be processed while new orders for these models will be fulfilled while supplies last on a first-come, first serve basis. Recommended replacements are outlined below. These replacements can only be purchased at Honeywell-authorized wholesale distributors and cannot be purchased directly from Honeywell.

Recommended Replacement FACP Overview:

The **Fire-Lite MS-2-L8** and **Fire-Lite MS-4** are two and four-zone conventional FACP, respectively. Both models provide reliable fire signaling protection for small-sized buildings and are compatible with conventional input devices such as two and four-wire detectors, pull stations, waterflow devices, tamper switches, and other normally open contact devices.

The **Fire-Lite MS-5UD-3** and **Fire-Lite MS-10UD-7** are five and ten-zone conventional FACP, respectively. Both models provide reliable fire signaling protection for small- to medium-sized buildings and include a built-in communicator for central station service and remote upload/download. Both models are also compatible with conventional input devices such as two and four-wire detectors, pull stations, waterflow devices, tamper switches, and other normally open contact devices.
